### VDA Key Legislation

- Foreign Trained Dentists – the lobbying team was able to fend off several foreign trained dental bills that had been drafted – all of which would have relaxed education requirements and allowed such dentists to practice in the Commonwealth. None of the bills were ultimately filed.
- Out-of-State Dental Licensure HB 981 (Scott) – this bill would have required the Board of Dentistry (BoD) to grant an application by endorsement to any applicant who was licensed. Currently, the BoD is authorized but not required to grant a license for applicants wishing to practice dentistry in Virginia. The VDA OPPOSED this legislation and, after significant discussion with the patron and others on the house health committee, the bill has DIED for the 2022 session.
- Med-Malpractice Cap Increase SB 599 (Stanley) – this bill would have raised the medical malpractice cap for dentists and oral surgeons around the Commonwealth. Along with other provider groups, the VDA vigorously OPPOSED this legislation and it was killed in the Senate Judiciary Committee.
- Dental School Faculty SB 590 (Pillion) – this bill was brought by the VCU School of Dentistry to allow the BoD to grant a faculty license to teach dentistry in an accredited dental program. The VDA HOD asked for criteria including a 3-year sunset clause and clarification on the level of clinical evaluation to be applied to this new section that would track with existing law. With those criteria included, it has PASSED the Senate unanimously and it will head to the House for consideration later this week or next.

### VDA – Key Budget Items

- Medicaid Reimbursement Increase. At the request of the VDA, Senators Barker (key finance committee member) and Saslaw (Majority Leader) are carrying budget amendments to increase Medicaid dental rates by 30%. Dental rates have not been increased in 17 years and the Senate seems poised to have a significant increase in their version of the budget. The House may be less inclined to have such an increase in their budget. The specific amount of a future increase will be worked out in the weeks ahead.
- Increasing Pediatric Anesthesia Access. At the request of the VDA, Senator Locke and Delegate Brewer are carrying budget amendments that require DMAS (Medicaid) to cover general anesthesia for all children under the age of 10 who undergo a dental procedure in cases where the doctor thinks it is necessary. Currently, the maximum age at which DMAS must approve is only 5. This will increase access to care for children and remove obstacles for pediatric dentists in particular. The fate of this measure will be decided over the next several weeks as budget negotiators determine key priorities.

For those who renew their licensure, certification, permit or registration, a permanent hard copy will be issued that contains no expiration date.

For those who are approved for initial licensure, certification, permit or registration, a permanent hard copy will be issued that contains no expiration date.

This final copy should be maintained, carried, or posted in accordance with relevant applicable laws and regulations. State health regulatory boards, employers, insurance providers and citizens seeking verification of current licensure status in the Commonwealth of Virginia may obtain this information via License Lookup.

## TWO BILLS OPPOSED BY VDA PASSED BY FOR THE YEAR

In the last week, two significant bills that could have negatively impacted dentistry in Virginia were passed by for the year, effectively closing their current path to become law. In both instances, the VDA Government affairs team worked with other medical associations, members of the relevant committees and the bills' authors to ensure that the legitimate concerns of dentists about the impact of the bills were addressed.

While stopping them this year was a success, dentists should remain wary of these proposals that could be reintroduced in future years in the General Assembly.

### House Bill 981 –

#### Health professions, certain; licensure by endorsement

The VDA raised serious concerns that this would amount to a legislative mandate that would force the Virginia Board of Dentistry to accept the most lenient state's standards for licensure, potentially putting patients at risk from dentists who don't meet Virginia's standards for dentists to safely and responsibly practice in the Commonwealth.

The VDA believes that further steps to increase licensure portability would be appropriately addressed through the au-

thority already granted to the Virginia Board of Dentistry and not by legislation mandating that the Board accept potentially unqualified candidates for licensure.

### SB 599

#### Medical malpractice actions, certain; limitation on recovery

This is a bill that has been proposed in past years, and risks increasing the cost of liability insurance – a cost that would be passed on to patients, with the greatest impact on patients who are paying out of pocket or struggle with the cost of dental care. Existing Virginia law includes a provision for a modest annual increase in the cap on recovery and we believe this policy strikes the proper balance in accountability without going too far to interfere with the ability of providers to care for their patients. The VDA testified against the bill in the Senate Committee on Judiciary, warning of its impact on cost and access to oral healthcare in Virginia, before the committee passed it by for the year.

The VDA Government Affairs team works year-round to ensure dentists have a seat at the table and speak with a unified voice when decisions are being made in Richmond.

With that being said, it's my pleasure to introduce a wine or two that I have enjoyed over the past few months.

To start let's establish a legend I will use to communicate cost.

\$: \$3-\$30

\$\$: \$31-\$60

Grace Town Petite Sirah 2018

Cost: \$

Varietal: 90% Petite Sirah and 10% Zinfandel

Region: Lodi, California

Alcohol: 13.5%

My take: This full body Sirah has a sweeter smell and not as much of a peppery finish which may be attributed to the addition of Zinfandel. The color is a dark ruby. It has the

aroma of a blackberry jam and even char wood (think of if you were enjoying a nice evening around a fire pit- with the smoke not blowing into your eyes). This wine is dry and the tannins are bold and grippy but the finish is smooth. It's a pretty complex sipping wine that also complements a variety of dishes.

Rombauer Vineyards: Carneros Chardonnay v 2020

Cost: \$\$

Varietal: 100% Chardonnay

Region: Carneros (Napa), California

Alcohol: 14.5%

My take: This is the best Chardonnay I have had so far. It was gifted to my husband by a coworker on the West Coast and I couldn't be more pleased. It has an exceptional balanced creamy texture and taste. It aged in American and French oak so you will note a subtle vanilla aroma as well as peach and lemon. It has a golden color. To my palate at least, it has a pleasant lingering lush finish. You need to try it and let me know what you think!

## ATTORNEY GENERAL MIYARES AT VDA’S “DAY ON THE HILL” BREAKFAST

On Friday, January 21, Attorney General Jason Miyares spoke at the opening breakfast for the VDA’s “Day on the Hill”. He previously served as the representative for district 82, replacing Bill DeSteph, who moved to the Senate in 2015. A good friend of **Dr. Dag Zapatero**, Mr. Miyares generously spent a good deal of time with the TDA dentists before his speech.

Mr. Miyares reflected on Virginia history in his speech, describing how some of the best and also some of the worst things have happened in the 400 year past of the Old Dominion. “The General Assembly is the longest continuous legislative body in the USA, dating back to the first colonial assembly in 1619. But we must not forget that 1 week later, at Point Comfort, the first slaves were delivered onto Virginia soil. We cannot change the past,” said the Attorney General, “but in the words of Dr. Martin Luther King, quoting the declaration of independence, this country must fulfill the promise to every American, that we hold these truths to be self-evident, that all men are created equal, with certain inalienable rights.”



Mr. Miyares described how his family escaped communist Cuba, and how his uncle was arrested at the Bay of Pigs rebellion. “People have died to get what we have every day” he said. He believes that he knows our challenges, he wants to make it easier for us to say, “you’re hired”, to new employees. He wants to find a way to make our jobs less difficult.

“The pandemic has made everything harder, and government needs to make it easier so we can care for people. Some good intentions can make things more difficult to work.” He believes it is important not to overburden businesses with regulations.

Addressing divisiveness so present in our country, he believes both parties can work together. He said, “There is no R or D on the graves in Arlington, they are all Americans. People who think differently are not your enemy.” He finished with a quote from President Reagan “how can you love your country if you don’t love your countrymen?” Mr. Miyares said the VDA is an excellent organization, all dentists should support it, and continue to communicate with state legislators.

## **VIRGINIA BOARD OF DENTISTRY OR VIRGINIA HEALTH WORKFORCE DEVELOPMENT AUTHORITY**

There is *one seat for a dentist* on the Virginia Board of Dentistry and *four seats for health and community health professionals* on the Virginia Healthcare Workforce Development Authority set to expire at the end of June. Those interested in applying should send in their applications soon to be considered. Learn more about these positions below.

### **Virginia Board of Dentistry**

The Board of Dentistry has significant responsibility in overseeing the practice of dentistry in the Commonwealth, interpreting and enforcing laws passed by the General Assembly and in issuing regulations that govern the profession.

To effectively promulgate regulations, the board must include individuals with a deep understanding of the profession and the impact that new regulations and guidance could have on dentists, their team members and on the communities in which they provide essential dental care.

Board members are appointed for terms of four years, and serve no more than two full successive terms. The Governor appoints ten members: seven dentists, two dental hygienists, and one citizen member. The professional members of the Board shall be licensed practitioners of dentistry and dental hygiene, of acknowledged ability in the profession, and must have practiced dentistry or dental hygiene in the Commonwealth for at least three years.

Service on the Board of Dentistry is one of the most

impactful ways in which a dentist can volunteer their time and expertise to improving oral healthcare in Virginia.

### **Virginia Health Workforce Development Authority**

The mission of the VHWDA is to facilitate the development of a statewide health professions pipeline that identifies, educates, recruits, and retains a diverse, appropriately geographically distributed and culturally competent quality workforce.

The VHWDA assesses health workforce needs in Virginia; sets priorities for the Area Health Education Center (AHEC) program; informs health care workforce policy; promotes strategies for health workforce pipeline development; supports collaborations between communities, businesses, and social organizations to facilitate recruitment and retention efforts; advocates reducing the student debt load of health professionals; identifies High Priority Target Areas (HPTAs) within each region of the Commonwealth; and aims to create innovative health workforce development models.
